



RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF RISK AGREEMENT

WHEREAS, in return for instruction in firearms, use of premise, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following: The undersigned agrees to indemnify, hold harmless and defend Tommy Jordan, S.A.F.T Academy, and/or the National Rifle Association of America, and any of its employees, volunteers, instructors, officers, (*hereinafter collectively referred to as SAFT*) from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to, or connected with: the discharge of firearms; the course of instruction; the Undersigned's participation in the course of instruction, the Undersigned's presence on or use of said Premises; and any and all acts or omissions of the Undersigned.

And should and such claim, demand or lawsuit arise or be asserted in any way or form whatsoever related thereto, whether arising under the laws of the United States or of any State, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend SAFT, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against SAFT, whether individually, jointly, or in solido with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned furthermore waives for himself/herself and his/her executors, administrators, assignees or heirs, any and all rights and claims for damages, loses, demands and any other actions whatsoever, which he/she may have or which may arise against SAFT, (including, but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or Undersigned's property), which may, in any way whatsoever, arise out of, be related to, or be connected with: the course of instruction; the Premises, including any latent defect in the Premises; the Undersigned's presences on or use of said Premises; shall not be liable for, and the Undersigned, on behalf of himself/herself and his/her executors, administrators, assignees or heirs, hereby expressly releases Tommy Jordan, SAFT, or the NRA from any and all such claims.

The Undersigned hereby expressly assumes the risk of entering the Premises and of taking part in activities on the Premises which include, but are not limited to, instruction in the use of firearms, the discharge of firearms and the firing of live ammunition. The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all SAFT range rules and procedures. This instrument binds the Undersigned and his/her executors, administrators, assignees or heirs.

Signing this form is voluntary. However, registration acceptance is dependent on signature.
